**WEDDING CEREMONY OFFICIATING                      \$300**

Wedding Officiant conducting ceremony and filing of marriage license.

**BEACH ELOPEMENT PACKAGE                                      \$400**

For couple and up to 25 guests. Includes: ceremony with minister, 10 digital photos of couple and guests, fresh rose-petal heart on the sand, and processing of marriage license. Couple will receive a CD with the photos. Couple is responsible for printing their own photos.

**FULL SERVICE BEACH WEDDING                                      \$895**

For couple and up to 25 guests. Includes: ceremony with minister, 200 digital photos of couple and guests. Photographer shoots for 1 hour, formal pictures before and after the wedding. Recorded music, fresh rose petal heart on the sand, and rose petal isle and processing of marriage license. Couple receives a CD with the photos. Couple is responsible for printing their own photos.

**PHOTO PACKAGE    \$450**

Includes: 90 minutes of photography, unlimited shots. Formal pictures are taken before and after the wedding. Couple receives a CD with the photos. Couple is responsible for printing their own photos.

**REHEARSAL    \$100**

Wedding Officiant participates with wedding party to practice ceremony. Includes coordination and conducting of processional and recessional if requested.

**MICROPHONE    \$50**

Includes portable microphone sound system provided by Wedding Officiant.

If the wedding is scheduled for an outdoor location, and weather conditions pose difficulty to have a wedding outdoors (rain months in California typically are October thru March), it is the responsibility of the bride and groom to find an alternative location for the wedding ceremony. If the Officiant must travel to the location of the wedding, and is hindered in his/her travel by unusual freeway or weather conditions, the terms of the contract shall be extended or negotiated to compensate all parties. If for any reason a wedding time and date are changed after remitting the deposit, The Wedding Officiant will try to provide availability for the new time and date. However, if The Wedding Officiant cannot provide availability, **the retainer will not be refunded**. In the event The Wedding Officiant is unable to conduct the wedding ceremony due to illness the Wedding Officiant will provide another Officiant to conduct the wedding ceremony.
